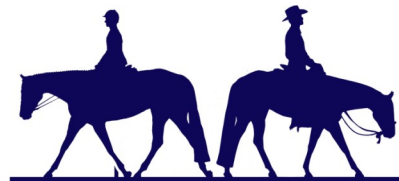

You need not be a member of the mid-penn circuit to ride in the mid-penn jack-pot classes.

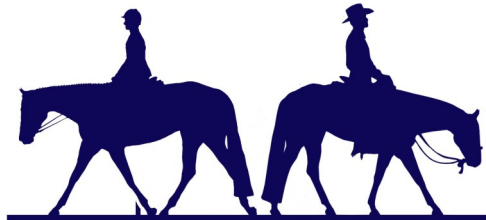

Aug 27 & 28, 2011—Since this is a horse show during an agricultural event the following health requirements will be strictly enforced

PA In-State Equine Health Requirements 2011:

1. A Certificate of Veterinary Inspection (CVI) issued after May 1, 2011 is required.
2. All animals must be free to infectious and contagious diseases
3. An Animal Owner or Caretaker's Veterinarian-Client-Patient Relationship (VCPR) form must accompany each animal, and must be presented upon arrival at the exhibition
4. All equine animals must be test negative for EIA by an official test with the 12 months prior to the opening date of the exhibition. Laboratory test results must accompany each animal to its final destination (a copy of the original lab report is acceptable) Foals less than six months of age accompanied by a dam which meets the above requirements are exempt from EIA testing requirements. If the foal is not accompanied by the dam, a copy of the dam's test results must accompany the foal to its final destination.
5. A current rabies vaccination administered by a licensed veterinarian is required for animals three months of age and older.

Out of State Equine Animals showing in PA requirements 2011:

1. A Certificate of Veterinary Inspection (CVI) issued within 30 days prior to the opening date of the exhibition is required
2. All animals must be free to infectious and contagious diseases
3. An Animal Owner or Caretaker's Veterinarian-Client-Patient Relationship (VCPR) form must accompany each animal, and must be presented upon arrival at the exhibition
4. All equine animals must be test negative for EIA by an official test with the 12 months prior to the opening date of the exhibition. Laboratory test results must accompany each animal to its final destination (a copy of the original lab report is acceptable) Foals less than six months of age accompanied by a dam which meets the above requirements are exempt from EIA testing requirements. If the foal is not accompanied by the dam, a copy of the dam's test results must accompany the foal to its final destination.
5. A current rabies vaccination administered by a licensed veterinarian is required for animals three months of age and older.
6. If an equine animal has resided in Texas or New Mexico for a cumulative total of 30 days or more within the six months preceding the date of entry into the Commonwealth, that animal must be test-negative by Piroplasmosis on a competitive enzyme-linked immunosorbent assay (c-ELISA) test, or a Department-approved equivalent test with the test occurring with the 30 days preceding entry into PA. The written laboratory test report, confirming compliance with the requirement described above, shall accompany the equine animal in transit to a destination within the Com of PA; and the date of test and the test results shall be written on the Certificate of Veterinary
